## Terms and Conditions - New Year's Eve 2023

Place Management NSW (**PMNSW**) ABN 51 437 725 177 is a NSW Government statutory entity within the Department of Planning and Environment.

Please note that the New Years Eve Fireworks for 2023 (**NYE23**) are presented by the Council of the City of Sydney ABN 29 143 862 138 (CoS). PMNSW is not responsible in the event that the NYE23 event or any part of it is cancelled by CoS.

Attendees must abide by the *Place Management NSW Regulation 2022* including the following Terms and Conditions at all PMNSW venues and at all times:

- At the point of entry of each PMNSW Venue for every PMNSW Event, attendees will be subject to bag searches and enhanced security screening before being permitted to enter the venue for the event.
- 2. Attendees will be required to produce identification (a Passport, Australian Driver's Licence, International Driver's Licence or Adult Proof of Age card) upon request prior to any alcohol purchase.
- 3. Attendees must not be under the influence of drugs and or alcohol while attending any PMNSW Event and must act responsibly and follow all reasonable requests made by NSW Police, Event organisers, PMNSW rangers and security staff and their agents (PMNSW Personnel) to ensure good order, security, safety, management and enjoyment of any PMNSW Venue. Attendees breaching these requirements or participating in anti-social behaviour including causing nuisance or annoyance to another person or persons may be refused entry or be required to leave the event area.
- 4. PMNSW Personnel may refuse any person entry to any PMNSW Event, and may require any such person to immediately leave the event area, where required for safety reasons or where the person is intoxicated and/or engaging in anti-social behaviour.
- 5. Attendees must NOT bring the following items into any PMNSW Event:
- alcohol;
- any illicit substances;
- any beverage that is not sealed, including thermoses;
- glassware or breakable containers;
- hard eskies or any soft esky larger than 20 litre capacity;
- offensive or illegal weapons including firearms, large knives, laser pointers and potential missiles;
- Umbrellas above 50cm in length, tarps, tents, shade structures or beach trolleys.
  No pegging or other penetration to the turf or ground is permitted;
- Fireworks, sparklers, open flames including candles, party poppers, balloons;
- BBQs and cooking equipment;

- balls, frisbees, skateboards, scooters, rollerblades, bicycles, kites or drones;
- animals or pets other than Assistance Dogs; and,
- any item which PMNSW considers dangerous, a threat to public safety or causing nuisance or offence.
  - 6. NYE23 is a smoke free event, however there will be designated smoking areas for the attendees who wish to smoke.
  - 7. Persons under the age of 18 attending any Licensed PMNSW Event must be accompanied and supervised by an adult parent or guardian at all times. Outside of Licensed areas, persons under the age of 16 must be supervised by an adult parent or guardian at all times.
  - 8. Attendees participating in any PMNSW Event do so at their own risk. PMNSW accepts no responsibility or liability arising from any injury, loss or damage of any kind suffered by any person or in respect of any property.
  - 9. By entering any PMNSW Venue for any PMNSW Event, attendees agree that they may be photographed and/or filmed. Attendees acknowledge that the images and/or film may be used for future promotional purposes related to the PMNSW Venue, at no cost and without further request for consent.
  - 10. No pass outs will be issued once attendees have entered any PMNSW Venue.
  - 11. PMNSW is not responsible for any interference to any PMNSW Event by third parties for safety reasons, including but not limited to NSW Police.
  - 12. No swimming is permitted at any PMNSW Venue during any PMNSW Event.
  - 13. No small watercraft may be used or objects thrown into waters at any PMNSW Venue including Pyrmont Bridge.
  - 14. No taking or attempting to harm fish at the Chinese Garden, Tumbalong Park, Cockle Bay Promenade, Pyrmont Bridge, or Barangaroo.
  - 15. Attendees must not harm the natural environment at any PMNSW venue including littering, climbing trees, digging, swimming, or harming any animal or its natural habitat.
  - 16. Attendees must not harm the built environment including damaging buildings or equipment, disturbing or polluting sealed surfaces, or climbing fixtures.
