Trader requirements & EXPECTATIONS

Product and Production Standards

Traders must:

- Prioritise Australian-made products
- Demonstrate transparent supply chains
- Use recycled or upcycled materials where possible
- Avoid mass-produced items
- Respect cultural integrity

Packing and Waste Reduction

Traders are required to:

- · Use only compostable or recyclable packaging
- Eliminate single-use plastics
- Minimise packaging materials
- Participate in market-wide waste reduction initiatives
- Ensure all chemicals and oils are responsibly removed and disposed of responsibly

Ethical Business Practices

Traders must adhere to:

- Fair trade principles
- Humane working conditions
- International human rights standards
- Transparent production methods
- No exploitative labour practices



Sustainable **Production**

Traders should demonstrate:

- · Local material sourcing
- Organic and sustainable ingredient selection
- Energy-efficient production methods
- Responsible chemical and waste management
- Circular economy principles

Energy and Emissions

Traders are required to:

- Use energy-efficient equipment and switch off appliances when not in use
- Must choose energy-efficient appliances when purchasing or leasing electrical equipment and appliances

Food Vendor Additional Requirements

Food traders must:

- Where possible source ingredients locally and seasonally
- Use sustainable food options to reduce food miles and avoid excessive packaging
- Offer vegetarian and vegan options
- Use reusable or compostable serving ware
- Minimise food waste
- Provide transparent animal welfare information
- ensure all graywater and oils are responsibly removed and disposed of responsibly

Diversity and Inclusion

Traders are expected to:

- Create welcoming environments for all customers
- Avoid discriminatory practices
